**Distinguished Members  
of the States General of the Kingdom of the Netherlands!**

**First of all, for 1450 days of terrible and brutal war, we want to sincerely thank You, Your Country and the People of the Kingdom of the Netherlands for helping the Ukrainians and the state of Ukraine in this difficult time of unprovoked armed aggression by Russia!**

As a human rights organization operating since 2011, we repeatedly and unfortunately constantly receive information about blatant cases of the destruction of democracy, suppression of freedom of speech and gross violations of human rights, usurpation of power, high-level corruption and nepotism among the leadership of Ukraine and the ruling elite.

We would like to emphasize and draw your attention to the fact that the information and facts recently presented in the world media are the honest truth and realities of modern Ukraine, no matter how Volodymyr Zelenskyy may justify himself. The facts speak for themselves! While the President of Ukraine, Volodymyr Zelensky, during his speech at the World Economic Forum in Davos, Switzerland, on January 22, 2026, and other global platforms, allows himself to brazenly accuse Ukraine's international partners of insufficient assistance and international reaction, as well as various events, his friends currently continue to profit corruptly and behave brazenly!

**A new shocking and truthful journalistic investigation from 06.02.2026 – The Godfather “at a distance”. According to the investigation, the former head of the Office of the President of Ukraine [REDACTED] [REDACTED] continues to influence high-ranking Ukrainian officials, summoning them to his office, which is located 500 meters from the Office of the President of Ukraine.

Investigative journalists managed to record how the Ambassador of Ukraine to Israel [REDACTED] [REDACTED] and the Advisor to the President of Ukraine [REDACTED] [REDACTED] came to [REDACTED] [REDACTED]'s office to meet with him. [REDACTED] [REDACTED] also arrived with his motorcade to the house of the Secretary of the National Security and Defense Council of Ukraine, Restum Umerov, in January 2026 to meet with him. It has been repeatedly recorded how [REDACTED]

[REDACTED]'s motorcade arrived at night at one of the villages near Kyiv, where the state dachas of high-ranking Ukrainian officials, including President Volodymyr Zelensky, are located.

It was also established that [REDACTED] [REDACTED] is still under the protection of the State Security of Ukraine, which is directly subordinated exclusively to the President of Ukraine.

According to the investigation, the lawyer of the former head of the Office of the President [REDACTED] [REDACTED] visited Israel, where he met with the lawyer of the person involved in the "Midas" case, businessman [REDACTED] [REDACTED] [REDACTED] flew to Tel Aviv together with the Ambassador of Ukraine to Israel [REDACTED] [REDACTED]. Before that, on January 15, [REDACTED] met with [REDACTED] near the Office of the President. And on January 25, a flight took off from Chisinau to Tel Aviv, on board of which [REDACTED] and [REDACTED] were. After arrival, the ambassador took Fomin in a company car to a hotel in Herzliya, where [REDACTED] [REDACTED] lives and is hiding, and the next day he arrived there again. UP sources in political circles claim that [REDACTED] sent [REDACTED]'s lawyer to negotiations related to the Mindich case.

**Those involved in the investigation, in addition to [REDACTED] [REDACTED] himself, personally confirmed the details of such meetings, and [REDACTED]'s lawyer confirmed such a trip to the state of Israel together with the Ukrainian ambassador.**

NABU and SAPO have exposed a scheme to embezzle funds for payments under the "green" tariff - for solar electricity. After the start of the full-scale war, the Russian Federation occupied part of the Zaporizhzhia region, solar power plants lost contact with the United Energy System of Ukraine, were damaged, and the personnel were evacuated. Despite this,

the enterprises controlled by the suspects continued to declare electricity production and receive payment for it at the "green" tariff, although in fact the electricity did not enter the Ukrainian energy system. "They reported false information about the generation volumes and technical readiness of the stations, in particular during a complete blackout. The money received was subsequently withdrawn through related companies. The total amount of losses was 141.3 million," the NABU noted.

**Currently, President Volodymyr Zelensky's ally and corruption suspect <sup>5.1.2.e</sup> together with his brother-accomplice, are hiding in the Federal Republic of Germany and the Republic of Austria, as he himself has repeatedly confirmed!**

According to the investigation, <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> people have once again organized history at Energoatom... about 2 billion hryvnias... right now, during the largest power outages. Some of <sup>5.1.2.e</sup>'s people (who still manage the state-owned enterprise Energoatom) in coordination with others (who sit in the National Commission for the Regulation of Energy and the Environment) quickly organized an abnormally large sale of energy resources, until prices skyrocketed... and a number of traders (close to the authorities) quickly bought up the entire volume. Some bought 300-400% more than usual. And literally a week later they sold much more expensively. Exactly 2 billion. And all this during January 8-22, 2026.

Information about a possible increase in price caps was known to a limited circle since January 8, but it was officially denied. The NEURC is publicly misleading the market, stating that price caps are not changing. NNEG Energoatom, knowing about the risk of changing the rules, for some reason sells a large amount of electricity at the old prices and in advance. TOP-15 traders sharply increase purchases (some by 3-4 times), while other market participants reduce them. After the price caps were raised, traders resell electricity at significantly higher prices. 2 billion UAH of unearned profit for Energoatom. This money becomes the profit of private traders. They earned 2 billion, and the state and the people lost. The largest profit, 400 million hryvnias, on electricity that Energoatom sold cheaply on the eve of a sharp price increase, went to D.Trading. The total profit of <sup>5.1.2.e</sup> <sup>5.1.2.e</sup>'s company and a dozen smaller traders could have been over 2 billion hryvnias, as <sup>5.1.2.e</sup>'s DTEK has already admitted!

**All suspects, according to journalistic investigations, especially the comrade of the President of Ukraine <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> are hiding in the State of Israel, and their funds are hidden in various financial havens and stable countries, such as Switzerland, Luxembourg and Liechtenstein.**

**In addition, due to constant massive shelling by Russia of peaceful cities and settlements, namely exclusively energy facilities and enterprises that produce and supply electricity and heat, hundreds of thousands and millions of Ukrainian citizens are currently left without heat, electricity and water for more than 20 hours or even more than several days! Unfortunately, also due to systemic corruption, in particular in the energy sector, and very often the inaction of the authorities, the situation in the energy sector of Ukraine is becoming critical and is taking on catastrophic proportions!** Also, on 09.12.2025 in Kyiv, a candidate of political sciences, a member of the International Association of Political Sciences and our authorized representative of the Legal Equality NGO in international missions, <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> was illegally detained by police officers

and military personnel, and later, as it became known later, at 12 o'clock he was taken to a medical facility on Polytechnic Street in Kyiv. In this building in the basement (like some kind of animal) he was illegally held for over 50 hours by military personnel who exerted moral pressure on him and inflicted bodily harm. Doctors and a lawyer were not allowed, he was without food and the necessary medicines for him, without explanation of the reasons and the absence of any procedural documents for such detention at that time.

He was released from captivity by police officers at the request of the honorary chairman Yaroslav Zakharchenko only 4 days later without explanations and the delivery of procedural and any other documents.

In addition, upon entering the said premises, our Honorary Chairman of the Organization, 5.1.2.e 5.1.2.e received threats of physical violence from representatives of military formations, who were also intoxicated. Arriving at the call of the Chairman, the police showed complete inaction, and the ambulance workers were also not allowed to see 5.1.2.e 5.1.2.e who needed medical assistance; medical assistance was provided only to 5.1.2.e 5.1.2.e

In our already deep conviction, these facts are nothing more than pressure on our human rights All-Ukrainian public organization for our active public and political activities regarding corruption in Ukraine, which has already led to the resignation of the Head of the Office of the President of Ukraine 5.1.2.e 5.1.2.e and other high-ranking officials!

When our Organization and members of the 5.1.2.e 5.1.2.e of Ukraine appealed to law enforcement agencies, the Minister of Defense and the top leadership of Ukraine regarding the mentioned case, who were perfectly informed about it, the reaction and results of the consideration were zero. At present, there is not even a single investigation!

Our organization has also repeatedly appealed to all of you in order to protect against attacks on the National Anti-Corruption Bureau of Ukraine.

The population of Ukraine now has a general and persistent impression that Ukraine, under the current leadership of the state, is returning to the times of Stalin's terror of 1937-1938.

Such terror against the citizens of Ukraine and such audacity, which cannot be called otherwise, did not exist even during the criminal rule of the President of 5.1.2.e 5.1.2.e

5.1.2.e  
Constant violations of the rights of conscripts and military personnel in Ukraine have already led to alarming figures regarding voluntary desertion from military units and desertion, which, according to official data, already number over 300 thousand criminal cases. Also, according to official reports, over 2 million citizens of Ukraine are wanted - allegedly for evading military service.

Ukrainian society was deeply outraged by systematic cases of corruption among the highest echelons of Ukrainian government, which were once again exposed by the National Anti-Corruption Bureau of Ukraine.

In addition, on January 14, 2026, former Prime Minister of Ukraine 5.1.2.e 5.1.2.e was suspected of corruption: everything that is known about the case and the searches of people's deputies - <https://www.unian.ua/politics/pidozra-timoshenko-nabu-opublikovalo-zapisi-rozmov-v-yakih-timoshenko-kazala-deputatam-yak-golosuvati-13255068.html> and <https://tsn.ua/politika/v-ofisi-batkivshchyny-obshuky-zmi-pyshut-pro-pidozru-tymoshenko-2999363.html>

According to the NABU investigation, 5.1.2.e 5.1.2.e spoke about considering personnel changes and receiving payments from a number of people's deputies for loyal behavior during the vote. Judging by the recordings of the conversations, the leader of the

Batkivshchyna party, [REDACTED] [REDACTED] gave instructions regarding votes in the [REDACTED] [REDACTED] which concerned the latest changes in the government. In particular, the dismissal of [REDACTED] [REDACTED] and [REDACTED] [REDACTED] as well as the resignation of [REDACTED] [REDACTED] from the post of head of the SBU. The corresponding records were published by the National Anti-Corruption Bureau of Ukraine (NABU).

In the record dated January 12, 2026, law enforcement officers recorded a discussion regarding the transfer of funds and the coordination of votes.

The transfer of funds was previously planned to deputies of the Ukrainian parliament from the presidential faction.

Also, on December 27, 2025, the case of payments to deputies in envelopes. NABU reported suspicion to 5 members of the [REDACTED] [REDACTED] of Ukraine from the presidential faction and named the amounts - <https://www.bbc.com/ukrainian/articles/c8984xkp1vwo>

NABU and SAPO reported suspicion to members of an organized criminal group, which included current people's deputies of Ukraine. According to NABU, the group ensured that parliamentarians received illegal benefits for the "necessary" vote. To organize the votes, according to the investigation, members of the criminal group sent instructions with the numbers of bills to a special group in the WhatsApp messenger. After the votes, the money was systematically transferred to individual deputies.

"At the same time, at least from September 2022 to November 2022, the amount of illegal gain was \$2,000, and at least from August 2025, it was already \$5,000," the Specialized Anti-Corruption Prosecutor's Office noted!

Also, without an investigation and a court decision, the Decrees of the President of Ukraine Volodymyr Zelensky, starting in 2022, have introduced groundless and illegal sanctions against tens of thousands of citizens and legal entities who are Ukrainians, which is a blatant violation of international law!

So recent events have forced us to break our silence, despite direct threats to our team and pressure from the Security Service of Ukraine (after recent appeals to you by international partners and the international community), especially regarding the lawyer, retired prosecutor of the city of Kyiv and honorary chairman of our organization [REDACTED] [REDACTED]

The corruption investigation is outrageous – “Zelensky’s friends have been ROBBING Energoatom all this time. They found a STRANGE scheme. That’s why they RAISED the tariffs” – <https://www.youtube.com/watch?v=4gnQ5VkJH4>.

Also, the news that the National Anti-Corruption Bureau of Ukraine has launched an investigation into possible corruption abuses by the heads of the Poltava Regional Military Administration during the construction of fortifications caused a great public outcry – <https://suspilne.media/amp/poltava/1106562-nabu-rozpocalo-rozsliduvanna-sodo-rozkradanna-kostiv-na-fortifikaciah-u-poltavskij-oblasti/> and <https://www.5.ua/regiony/miliony-na-butaforiuu-fortyfikatsii-na-donechchyni-vyivylisia-feikom-khto-zaimavsia-obrudkoiu-359214.html>.

According to the investigation, at that time the Poltava Regional State Administration was headed by [REDACTED] [REDACTED] who now heads the State Financial Monitoring Service. His deputies were also not punished, on the contrary, they received new positions. And the shell company also won a billion-dollar tender for road repairs.

It should be noted that the heads of regional military administrations are personally appointed by President Volodymyr Zelensky, and their work is currently supervised by the former head of his office, [REDACTED] [REDACTED]

The real owner of Fire Point may be President Volodymyr Zelensky's friend and co-founder of the Kvartal 95 studio, <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> Unfortunately, this does not surprise us, because the journalistic investigation of 07/30/2025 proves how <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> the curator of subsoil in Ukraine, lives - a confidant of Volodymyr Zelensky and <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> - and where the President of Ukraine himself often visited - EARNING OF MINDICH'S APARTMENT: "ZELENSKIY'S VACATION and GOLDEN TOILET. This is where the list of the "Servant of the People" faction to the Verkhovna Rada of Ukraine was formed" - <https://www.youtube.com/watch?v=gV0mnQJX6vs>.

If the esteemed President of Ukraine Volodymyr Zelensky and the former head of the office and his friend <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> respected national and international law, they would not only prevent everything that is happening in Ukraine that has nothing to do with war, but would also fulfill the requirements of the Constitution of Ukraine.

For example, Volodymyr Zelensky has been the President of Ukraine for 7 years, which contradicts the requirements of Article 103 of the Constitution of Ukraine, which provides for a term of office of 5 years. President Volodymyr Zelensky should resign after the end of his five-year term in accordance with Articles 108-109 of the Constitution of Ukraine, and not try to concentrate all power in one center - the Office of the President of Ukraine, which is de facto headed by his friend <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> even after his dismissal.

And war and martial law are not an obstacle to democratic processes in Ukraine, since the practice of recent months has shown that Article 10 of the Law of Ukraine "On the Legal Regime of Martial Law", which allegedly prohibits the election of the President of Ukraine, can be easily changed, although the Constitution of Ukraine does not contain such a prohibition, since martial law did not prevent the change of the Government of Ukraine headed by <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> on July 17, 2025, which is now fully controlled by the Office of the President of Ukraine, which was even publicly confirmed by President Zelensky himself. The above may not only contribute to reputational losses in the international arena, but also threaten the processes of Ukraine's European integration.

In addition, Prosecutor <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> is the only one who has not been afraid to speak publicly and give interviews to national TV channels recently, because he has nothing to fear, which cannot be said about others. The majority in Ukraine began to say that the state needs a new Prosecutor General and President of Ukraine, such as <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> who is truly honest, frank, not afraid of pressure and tells the truth.

Now, after numerous threats and pressure, Mr. <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> <sup>5.1.2.e</sup> has resigned from the prosecutor's office, and now, as the honorary head of the NGO "Legal Equality", he continues to protect human and civil rights in Ukraine!

However, it seems that an honest Prosecutor General would not be beneficial to President Volodymyr Zelensky, because his team and friends would not be able to do what they want. One of the confirmations of this is the consent of the [REDACTED] [REDACTED] of Ukraine dated 06/17/2025 to the appointment of [REDACTED] [REDACTED] as Prosecutor General.

The appointment of [REDACTED] [REDACTED] as Prosecutor General was a gross violation of Article 131-1 of the Constitution of Ukraine, Clause 4 of Part 40 of the Law of Ukraine "On the Prosecutor's Office" and especially Part 4 of Article 212 of the Law of Ukraine "On the Rules of Procedure of the Verkhovna Rada of Ukraine" – when the President of Ukraine is legally obliged to be present in Parliament in person, and not to be in another part of the world at that time. Therefore, it is not surprising that the Chairman of the [REDACTED] [REDACTED] was also absent for some reason!

[REDACTED] [REDACTED] avoided the certification of prosecutors because there were too many questions about his integrity.

His appointment as Prosecutor General in violation of the laws and the Constitution of Ukraine is a cynical spit in the face of civil society and the people of Ukraine, as well as the entire international community.

The illegal appointment of [REDACTED] [REDACTED] a man of [REDACTED] [REDACTED] to a leading position in the prosecutor's office, which is supposed to control the rule of law, is epic and audacious!

A shocking investigation revealed that her older brother had defected to the Russian side, and her father was engaged in business in occupied Crimea.

Also on 12/20/2024, the media published a journalistic investigation into corruption deals at the level of the first persons of the Ukrainian government together with their accomplices on the Internet – <https://www.pravda.com.ua/articles/2024/12/20/7489883/>.

According to the investigation, in the third year of Russia's full-scale invasion, unknown persons are covering up large assets in the rear in the interests of well-known top officials, namely the unique enterprise "Karpatneftekhim" (Odessa region).

So the story of how the country's largest chemical enterprise was seized by the Office of the President, namely its head [REDACTED] [REDACTED] by registering the ownership of this real estate in the name of a fictitious individual entrepreneur, is no longer a secret for the capital's elite of Ukraine.

- The head of the Odessa Regional Military Administration, [REDACTED] [REDACTED] is suspected of taking assets abroad!

As we previously reported, the head of the Kyiv City Prosecutor's Office, [REDACTED] [REDACTED] [REDACTED] was simultaneously appointed head of the Odessa Regional State Administration on May 30, 2023, under the "secondment" procedure. For almost three years, one person held two unrelated positions, cynically using the legal regime of martial law. He was dismissed from the post of head of the Kyiv Prosecutor's Office only in December 2025 and after our numerous appeals!

All of the above cynically occurs during the armed aggression of the Russian Federation and is nothing more than corruption and contempt for society.

It is no secret that Kiper has very friendly relations with the former head of the Office of the President of Ukraine Andriy Yermak and the deputy head of the Office of the President Oleg Tatarov.

Unfortunately, there are no investigations and results regarding the above facts.

In previous appeals, we have also reported on numerous other facts of high-level corruption in Ukraine. However, the authorities and law enforcement agencies have been completely inactive in relation to these reports, as well as the facts set out in journalistic investigations.
